The underlying question here, which would make a difference for most departments, is whether this is a current or potential county vendor. If so, then the general travel ban would preclude it for all county employees. If it is not a vendor, then it could be accepted as long as the trip, lodging and all incidental benefits are disclosed as a gift. However, for procurement employees, who have an administrative no gift rule, depending on how Miriam interprets it, that might preclude them from accepting it. Also, if this happens to be an organization that the county belongs to, then it would be permissible for county employees to accept it, with appropriate disclosure.
