Ms. Davis-Raiford,

The Ethics Commission staff has determined that the County Ethics Code is not violated if a member of your immediate family receives social services offered by the County department that employs you, as long as the family member is eligible to receive these benefits and you have not used your official position to obtain special assistance for her that is not available to others similarly situated. *See* Miami-Dade County Code at Sec. 2-11.1 (g).

We understand that you are the Director of the Community Action and Human Services Department and that many of the social services your family member will qualify for legally are provide through your department.

We find that the general rule found at Sec. 2-11.1 (c)(2) of the County Code—prohibiting individuals from entering into financial contracts with a department that employs a family member—is not germane. The intent of at Sec. 2-11.1 (c)(2) is not to impose restrictions in the delivery of social services to qualified individuals, but rather to prevent family insiders from obtaining improper pecuniary benefits through contracts with the County.

To avoid the appearance of impropriety, you stated that you will request that the Public Housing and Community Development Agency manage your family member's case rather than manage the case in your department. This action is not required by the County Ethics Code, but we appreciate your efforts in maintaining the public's trust.
