Hello Shania,

To be clear, *not all* former County employees are required to file final financial disclosure forms—only those former County employees who, either under State or County law, were required to file financial disclosures while they were employed, based on their positions with the County.

If the County employee was required to file under State law (*e.g.*, a person with authority to make purchases in excess of \$20,000), the County employee must file State Form 1F within 60 days of leaving County employment.

If the County employee was required to file under the County Code at Sec. 2-11.1 (i)(2), the County employee may file any of the forms enumerated in the County Code at Sec. 2-11.1 (i)(1) by July 1st of the year following the last year he/she was employed by the County.

I'm assuming that the former Director of the Homeless Trust was required to file under State law. Consequently, he should have filed State Form 1F within 60 days of leaving County employment. If this assumption is correct and the former Director has not filed, he should file State Form 1F as soon as possible.

Hi Shania,

I trust this e-mail finds you well. Let me start from the beginning. My present director Hilda Fernandez asked me to remind some former employees of their obligation to file a financial

disclosure form. Our former director David Raymond is among those. However, he retired from the county (as is one of the other employees that is separated from county service).

He responded to me ([see below](#)) saying that according to what he researched on the Elections link, he is supposed to fill out a Form F within the final 60 days of employment. Said form is supposed to be provided by HR, which according to him was not. I guess the fundamental question is: Do former county employees separated from service via retirement have to file a financial disclosure? Please advise.
