Mr. Planas,

After speaking with William Grodnick, City Attorney at the City of Hialeah, I am sorry to inform you that you cannot accept part-time employment with the City of Hialeah because G&R Electric Corp., a company owned by your parents, has contracts with the City.

The City of Hialeah Ethics Code at Sec. 26-32 specifically prohibits City employees and their family members from contracting with the City. The City Code does not include a waiver provision to overcome this ban.

Good afternoon, it was a pleasure speaking with you a couple of days ago.

As per our discussion, here is a summary of what you asked for as well as a description of what I am trying to do:

- I am currently trying to obtain a part-time and/or on call electrical inspector position with the City of Hialeah. Main reason is to have some additional income as well as gain more knowledge
- As we spoke, I am also an employee in my fathers electrical contractor business. He and my mother, Maria T Planas, are the owners of G&R Electric Corp. My father is also the qualifier and I am the secondary qualifier

- We are currently, and have in the past, worked on contracts for the City of Hialeah. At this moment we have (2) contracts. One for a 72 unit elderly housing building, that will be complete within the next month, and the other is for a recreation center that should be complete by the end of the year.
- These are public bids and we will continue to try and win more bids as they are available.
- We also sometimes have smaller jobs within the city of hialeah, not owned by the city.
- I understand that I will not inspect my company's work or anything related to it. I just seek official instructions or clarification from the Ethics board before I proceed to accept any position.

I have also copied Mr. John Hall to this email. He is the city Cheif electrical inspector. I assume that I will be working under him.

Please let me know if you need any other information in order to have an official recommendation or letter.
