I would like to get some advice regarding a situation I have with a contractor C & C Marble and Tile. This company did not complete the work they were contracted to do. We paid them fully for the services before the job was completed. This was the biggest mistake. We hired a lawyer and we won a judgement against the company however they reopened a new company. This is so dishonest of companies. We originally hired them thinking they were reputable and licensed. We even contacted the Miami-Dade contacting licensing over at the West Dade office and they ordered the company to pay however to date no monetary compensations were paid. All we wanted was to complete the work or refund us our money for the services that was not completed. We have spent so much in legal fees etc. all I cannot believe such dishonesty can occur. It is wrong that this company continues to operate simply by reopening a new company as if nothing was done wrongfully. This I feel should not be allowed and this company should be penalized.

I have all of the documentation regarding this contractor, judgement etc. can you please advise if such a situation can be handled by the ethics commission.
