Ms. Mendez:

You have inquired on behalf of Angel Zayon, Chief of Communications and Protocol for the City of Miami, regarding whether expenses paid by Aeromexico for a trip by Mr. Zayon to Mexico in order to strengthen a "sister city" relationship as well as to promote tourism, investments and international trade, should be disclosed as a gift on FORM 9 Quarterly Gift Disclosure. You have informed that Aeromexico is not a county lobbyist, vendor or contractor. Assuming that there is no quid pro quo involved and that the complimentary travel is not connected to any decision being made by the city affecting the private interest of the donor (in which case the gift could be prohibited under Section 2-11.1(e) of the County Ethics Ordinance), and there is some legitimate public purpose involved in the trip, such that it justifies the expenditure of city resources in Mr. Zayon's traveling out of the country to perform these services, then the acceptance of the travel is not prohibited. However, insofar as it is being paid not by the city but by a private entity and has a value of more than \$100, it must be reported as a gift on the proper disclosure form pursuant to Section 2-11.1(e)(4). This opinion is consistent with prior opinions we have provided concerning Mayor Regalado and Commissioner Sarnoff.
