Mr. Fallon,

You requested an opinion regarding whether your son can accept a scholarship provided by the engineering firm Brown and Caldwell (B&C), a County Vendor. You are a County employee employed in the Miami-Dade Water and Sewer Department as a Planning Division Chief. You advise that you do not currently oversee, supervise, or administer any B&C projects.

As background, your son is a high school senior at Coral Gables High (CGHS) who will be attending college next year. CGHS advised CGHS students of the scholarship funded by B&C and your son applied. You did not know that your son applied for the scholarship. We understand that B&C funds \$1000 scholarships for CGHS students interested in engineering. The scholarship funds are deposited directly to the College the student will be attending and B&C has the sole responsibility to administer the program and make decisions about awards.

The Ethics commission has previously opined that the Ethics Code **does not prohibit** family members of County employees from applying to and receiving a scholarship administered by a County vendor as long as the County employee does not improperly use his or her County employment to gain advantage over other applicants in the process. See RQO 99-60, INQ 10-31 and INQ 10-191.

The Ethics Code at Sec. 2-11.1(e)(3) prohibits County employees from accepting gifts intended to influence them to take official action or in response to an official action taken. In this case, however, it is your son who is the recipient. Therefore, since B&C scholarships are available to all CGHS students who meet the scholarship criteria and are not aimed at a particular County employee or his or her family member based on a direct personal service provided or to be provided, **we do not find that scholarships administered solely by B&C under the circumstances you describe violate the Ethics Code.**

In addition, we refer you to Fla. Stat 112.3148. This statute prohibits "covered individuals" and their immediate family members from receiving gifts over \$100 from agency lobbyists, vendors, or political committees. Good Afternoon,

I have a son who is a high school senior and will be attending college next year. He informed me yesterday that he has been awarded a \$1,000 scholarship from the firm Brown and Caldwell. He found out about this program at school and it is for students who intend to pursue an engineering degree as he does. I had no knowledge of his having applied for this scholarship. In order to apply, he filled in an application, wrote an essay and obtained two recommendation letters.

Brown and Caldwell has an active Agreement and has had numerous Agreements in the past to provide engineering services to the Miami-Dade Water and Sewer Department. I have had no involvement with the current Agreement except for contacting them yesterday to conduct a hydraulic study as indicated in the attached E-mails. I do not intend to participate in fee negotiations or administration of this assignment. We will use the results of the proposed study in our planning activities for the Department. The current Agreement is to provide service in connection with the maintenance of our North District Wastewater Treatment Plant. My work is in facilities Planning. I was involved in fee negotiations and project review and payment approval activities in the past with regard to their contracts pertaining to my area of work (8-10 years ago or in the case of their working as a subconsultant about 6 years ago).
