Dear Mr. Chatlos,

It was a pleasure speaking with you recently to discuss the issue of Mom & Pop Grants. You have inquired regarding who would need to request an Ethics Opinion when applying for a Mom & Pop Grant.

You advise that Commissioner Zapata's office is reviewing the application process for Mom and Pop Grants and you emailed me a copy of the current application that is distributed by the Commissioner's office. The current application states that elected officials and board members must obtain written approval from the Ethics Commission. You are correct that under the County Ethics Code at Section 2-11.1 (c), immediate family members (spouse, domestic partner, parents, stepparents, children and step children) of public officials should also be directed to obtain an opinion from the Ethics Commission. Additionally, pursuant to Section (c), **County employees** and their immediate family members should be added to the application since they would be required to obtain an Ethics Opinion.
