Ms. Casas-Perez:

County employees may not accept travel expenses from County vendors, as per Sec. 2-11.1 (w) of the County Code. Travel expenses include, but are not limited to, transportation, lodging, meals, registration fees and incidentals. Only the Board of County Commissioners (BCC) may waive this prohibition by majority vote.

Consequently, Ms. Karen Grassi of the County GIS Division may not accept a complimentary registration (approximate value of \$450.00 to \$550.00) from the Environmental System Research Institute (ESRI) if she attends ESRI's 2014 Southeast Regional Conference in Charlotte, North Carolina. Ms. Grassi's department may apply to the BCC which may waive this prohibition by a majority vote.

ESRI's GIS technology is the Enterprise standard for the County location mapping systems. The GIS Division often submits many of the Miami-Dade County's projects and works for recognition, collaboration and transparency (i.e. NACO and PTI).

The Bike305 story map project was submitted last year in support of the Southeast Regional Users Conference. During which time, the conference attendees voted on all submissions and the Miami-Dade County's Bike305 mapping application received the most votes from conference participants and thereby earned the top award in the Map & App Gallery competition. As a result, the County was awarded a complimentary registration to their upcoming conference.
