Since your job responsibilities as an Accounts Clerk with the Miami-Dade County Parks and Recreation Department (Crandon Park) will not require your involvement in any aspect of the contract, you may contract to provide Section 8 housing.



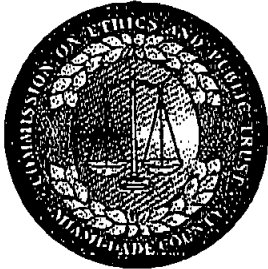



Looking forward to hearing from you, soon.

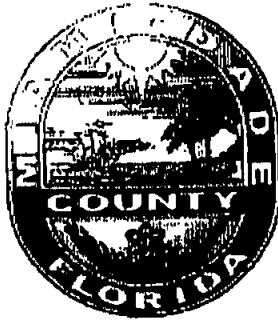
